**MINORITY BUSINESS POLICY**

Minority participation is encouraged in this and all other procurements by state agencies. "Minority" is defined by Arkansas Code Annotated §1-2-503 as "black or African American, Hispanic American, American Indian or Native American, Asian, and Islander". The Arkansas Economic Development Commission of the Department of Economic Development conducts a certification process for minority businesses. Bidders unable to include minority-owned businesses as subcontractors "may explain the circumstances preventing minority inclusion".

**TERM OF CONTRACT & RENEWAL:**

DISCOUNTS ARE TO REMAIN FIRM UNTIL THE END OF THE CONTRACT TERM or any extensions thereof. The resulting contract will be in effect for 1 (one) year term. The Office of State Procurement reserves the option to renew this contract in accordance with the original terms of the contract, upon mutual agreement, for up to 6 (six) renewal periods, in one (1) year increments or a portion thereof, but not to exceed a total contract term of seven (7) years.

**PRICE ESCALATIONS:**

PRICE INCREASES WILL ONLY BE ALLOWED ONCE every 3 months if the vendor can prove that the price increase is necessary and based on an increase in the market price. Price increases will not be granted to cover an increase in margin, profit, overhead, or fuel/freight charges. Price change request will be accepted on February 1st, May 1st, August 1st, and November 1st of the contract year.

Price escalation request from vendors MUST be submitted in the same format as the posted contract. OSP will not be responsible for manipulating the vendor's price list to match the posted contract. It MUST be the responsibility of the vendor to separate the prices of their price list by location to match the posted contract. Any price increase request not submitted in the appropriate format will be rejected.

**INSPECTION:**

All products must come from a federally inspected plant. All meat items preceded by an Institutional Meat Purchasing number must be federally inspected before delivery and must be properly labeled according to the Food, Drug and Cosmetic Act. Meat requested frozen must be inspected while fresh.

**GENERAL:**

1. Bidder must state brand name and pack on applicable items or bid will be rejected.
2. Failure to bid in unit of measure requested may result in rejection of bid. Pack or weight, if different from requested size, is subject to approval by using agency.
3. No distressed or salvaged food will be accepted.
4. Master containers will be marked with date of pack.

**QUANTITIES:**

Quantities indicated reflect estimates only and may not be exact requirements.

**AUTHORIZATION FOR SHIPMENT:**

Purchase order from the using agency will authorize shipment. Orders shall be placed with the vendor seven (7) days prior to the specified delivery date.

**SPECIFICATIONS:**

1. Fat content of regular ground beef may not exceed 25%. Fat content will be determined by laboratory analysis. Agencies may request fat content as low as 20%.
2. Agency receiving personnel shall check all products when delivered and notify the Office of State Procurement (Amy Stoddard) if they do not conform to specifications.
3. Arrangements may be made for a Federal Inspector to examine the product to verify nonconformance.

**SUBSTITUTION OF AWARDED ITEM:**

If vendor requests a substitution of an item awarded to his company, the substitution must be approved by Amy Stoddard, CPPB, or Rick Smith, CPPB of the Office of State Procurement, prior to shipment of substitution to using agency. Failure to request approval will result in cancellation of the item involved.

**METHOD OF AWARD:**

1. Agencies will be allowed to purchase from any of the awarded vendors during the term of the contract. The decision of which vendor to purchase from will be made solely at the agency's discretion.
2. Bidders must be able to deliver to all agencies listed in the solicitation.

**PACK DATES:**

All products delivered shall be from the latest season's pack. Pack dates on all Items to be delivered may not be more than 120 days old unless written permission is given by the receiving facility. All products will be delivered in first-class condition. No damaged cans, boxes or bags will be accepted. Damaged packages, i.e., torn, crushed or otherwise exposed to the elements or damaged in a manner as to lose eye appeal will be refused. Contractor will be responsible for replacement of any item so refused. **NO DISTRESSED OR SALVAGED FOOD WILL BE ACCEPTED.**

**PACKAGING/TRANSPORTING:**

1. Products delivered shall be processed and packed in accordance with good commercial practice and shall conform to all applicable standards promulgated under the Federal Food, Drug, and Cosmetic Act in effect at time of shipment.
2. Shipping cases shall be plainly marked on one end describing name and brand of product, quantity, and weight of cartons.
3. Products must be transported to point of delivery in a vehicle equipped and able to maintain temperature of chilled products not to exceed 45 degrees F and frozen products at an internal temperature of 0 degrees to -15 degrees F.

**REIMBURSEMENT FOR DAMAGED (UNUSABLE) PRODUCT:**

All returns, such as dented cans, broken cases, or unusable product shall be picked up by the vendor within thirty days. After thirty days the agency may discard the product. If replacement or credit is not made within thirty days the credit will be deducted from the vendor's unpaid invoice.

**DELIVERY:**

1. Delivery is F.O.B. Destination Prepaid Freight –Inside Delivery with seven (7) calendar days after receipt of purchase order or as specified on Agency purchase order to various FOB Points as listed in the bid.
2. All Transportation expenses will be the responsibility of the vendor..
3. Contractors must notify the Office of State Procurement of inability to deliver.
4. All deliveries shall be coordinated with the agency, unloaded at the facility, and arranged for inside delivery.
5. Some agency's have special limitations as to truck size, delivery dock and material handling capabilities that must be adhered to. Such special instructions will be indicated on the agency's purchase order.
6. Damaged packages, i.e., torn, crushed, or otherwise exposed to the elements or damaged in a manner so as to lose eye appeal will be refused. Vendor will be responsible for replacement of any item so refused.
7. All deliveries will be made between 8:00 a.m. and 4:00 p.m. on the date specified or as directed by the ordering agency.

**CERTIFICATION/GRADE:**

1. The State may require the contractor to furnish USDA grade certification on any or all items
2. All fryers, hens, and turkeys must be plant grade USDA inspected. Certification and proof of plant grade inspection must be provided upon request of the agency or OSP.

**CONDITIONS OF AWARD:**

1. Bidders must bid the package size requested on commercial products, sizes other than requested will not be considered.
2. Chicken products will not be considered as alternatives for products specified with Turkey.
3. Turkey products will not be considered as alternatives for products specified with Chicken.
4. Soybean Oil products will not be considered as alternatives for products specified with Vegetable Oil.
5. Vegetable Oil products will not be considered as alternatives for products specified with Soybean Oil.
6. "All or None" bids will not be considered. Bidder specified conditions will not be accepted.

**PAST PERFORMANCE:**

In accordance with provisions of The State Procurement Law, R7:19-11-229 Competitive Sealed Bidding- Bid Evaluation paragraph (E) (i) & (ii): a vendor's past performance with the state may be used in the evaluation of any offer made in response to this solicitation. The past performance should not be greater than three years old and must be supported by written documentation on file in the Office of State Procurement at the time of the bid opening. Documentation may be in the form of either a written or electronic report, VPR, memo, file or any other appropriate authenticated notation of performance to the vendor file.

**SHELF LIFE:**

1. Six Months – Powdered milk, dried fruit and vegetables and crackers
2. One Year – Canned, condensed meat and vegetable soups, canned fruits, fruit juice and canned vegetables, peanut butter, jelly and nuts.
3. All other items must have a 60-day shelf life from the time of delivery.
4. All products must be from the latest seasons pack and have a packaging date no longer than 9 months before the actual delivery date to any state agency.
5. Frozen products at no time shall have exceeded USDA guidelines for temperature, packaging, storage, and transportation.

These terms & conditions, the requirements of the Invitation for Bid (hereby included by this reference), and the Procurement Laws and Rules of the State of Arkansas will govern this contract.

## Terms & Conditions

### Terms & Conditions

1. **GENERAL:** Any special terms and conditions included in the invitation for bid override these standard terms and conditions. The standard terms and conditions and any special terms and conditions become part of any contract entered into if any or all parts of the bid are accepted by the State of Arkansas.
2. **ACCEPTANCE AND REJECTION:** The state reserves the right to accept or reject all or reject all or any part of a bid or any and all bids, to waive minor technicalities, and to award the bid to best serve the interest of the state.
3. **BID SUBMISSION:** Bids must be submitted to the Office of State Procurement on this form, with attachments when appropriate, on or before the date and time specified for bid opening. If this form is not used, the bid may be rejected. The bid must be typed or printed in ink. The signature must be in ink. Unsigned bids will be disqualified. The person signing the bid should show title or authority to bind his firm in a contract. Each bid should be placed in a separate envelope completely and properly identified. Late bids will not be considered under any circumstances.
4. **PRICES:** Quota F.O.B. destination. Bid the unit price. In case of errors in extension, unit prices shall govern. Prices are firm and not subject to escalation unless otherwise specified in the bid invitation. Unless otherwise specified, the bid must be firm for acceptance for thirty days from the bid opening date. "Discount from list" bids are not acceptable unless requested in the bid invitation.
5. **QUANTITIES:** Quantities stated in term contracts are estimates only, and are not guaranteed. Bid unit price on the estimated quantity and unit of measure specified. The state may order more or less than the estimated quantity on term contracts. Quantities stated on firm contracts are actual requirements of the ordering agency.
6. **BRAND NAME REFERENCES:** Any catalog brand name or manufacturer's reference used in the bid invitation is descriptive only, not restrictive, and used to indicate the type and quality desired. Bids on brands of like nature and quality will be considered. If bidding on other than referenced specifications, the bid must show the manufacturer, brand or trade name, and other descriptions, and should include the manufacturer's illustrations and complete descriptions of the product offered. The state reserves the right to determine whether a substitute offered is equivalent to and meets the standards of the item specified, and the state may require the bidder to supply additional descriptive material. The bidder guarantees that the product offered will meet or exceed specifications identified in this bid invitation. If the bidder takes no exception to specifications or reference data in this bid he will be required to furnish the product according to brand names, numbers, etc., as specified in the invitation.
7. **GUARANTY:** All items bid shall be newly manufactured, in first-class condition, latest model and design, including, where applicable, containers suitable for shipment and storage, unless otherwise indicated in the bid invitation. The bidder hereby guarantees that everything furnished hereunder will be free from defects in design, workmanship and material, that if sold by drawing, sample or specification, it will conform thereto and will serve the function for which it was furnished. The bidder further guarantees that if the items furnished hereunder are to be installed by the bidder, such items will function properly when installed. The bidder also guarantees that all applicable laws have been complied with relating to construction, packaging, labeling and registration. The bidder's obligations under this paragraph shall survive for a period of one year from the date of delivery, unless otherwise specified herein.
8. **SAMPLES:** Samples or demonstrators, when requested, must be furnished free of expense to the state. Each sample should be marked with the bidder's name and address, bid number and item number. If samples are not destroyed during reasonable examination they will be returned at bidder's expense, if requested, within ten days following the opening of bids. All demonstrators will be returned after reasonable examination.
9. **TESTING PROCEDURES FOR SPECIFICATIONS COMPLIANCE:** Tests may be performed on samples or demonstrators submitted with the bid or on samples taken from the regular shipment. In the event products tested fail to meet or exceed all conditions and requirements of the specifications, the cost of the sample used and the reasonable cost of the testing shall be borne by the bidder.
10. **AMENDMENTS:** The bid cannot be altered or amended after the bid opening except as permitted by regulation.
11. **TAXES AND TRADE DISCOUNTS:** Do not include state or local sales taxes in the bid price. Trade discounts should be deducted from the unit price and the net price should be shown in the bid.

## Terms & Conditions

12. **AWARD:** Term Contracts: A contract award will be issued to the successful bidder. It results in a binding obligation without further action by either party. This award does not authorize shipment. Shipment is authorized by the receipt of a purchase order from the ordering agency. Firm Contracts: A written state purchase order authorizing shipment will be furnished to the successful bidder.

13. **LENGTH OF CONTRACT:** The invitation for bid will show the period of time the term contract will be in effect.

14. **DELIVERY ON FIRM CONTRACTS:** The invitation for bid will show the number of days to place a commodity in the ordering agency's designated location under normal conditions. If the bidder cannot meet the stated delivery, alternate delivery schedules may become a factor in an award. The Office of State Procurement has the right to extend delivery if reasons appear valid. If the date is not acceptable, the agency may buy elsewhere and any additional cost will be borne by the vendor.

15. **DELIVERY REQUIREMENTS:** No substitutions or cancellations are permitted without written approval of the Office of State Procurement. Delivery shall be made during agency work hours only 8:00 a.m. to 4:30 p.m., unless prior approval for other delivery has been obtained from the agency. Packing memoranda shall be enclosed with each shipment.

16. **STORAGE:** The ordering agency is responsible for storage if the contractor delivers within the time required and the agency cannot accept delivery.

17. **DEFAULT:** All commodities furnished will be subject to inspection and acceptance of the ordering agency after delivery. Back orders, default in promised delivery, or failure to meet specifications authorize the Office of State Procurement to cancel this contract or any portion of it and reasonably purchase commodities elsewhere and charge full increase, if any, in cost and handling to the defaulting contractor. The contractor must give written notice to the Office of State Procurement and ordering agency of the reason and the expected delivery date. Consistent failure to meet delivery without a valid reason may cause removal from the bidders list or suspension of eligibility for award.

18. **VARIATION IN QUANTITY:** The state assumes no liability for commodities produced, processed or shipped in excess of the amount specified on the agency's purchase order.

19. **INVOICING:** The contractor shall be paid upon the completion of all of the following: (1) submission of an original and the specified number of copies of a properly itemized invoice showing the bid and purchase order numbers, where itemized in the invitation for bid, (2) delivery and acceptance of the commodities and (3) proper and legal processing of the invoice by all necessary state agencies. Invoices must be sent to the "Invoice To" point shown on the purchase order.

20. **STATE PROPERTY:** Any specifications, drawings, technical information, dies, cuts, negatives, positives, data or any other commodity furnished to the contractor hereunder or in contemplation hereof or developed by the contractor for use hereunder shall remain property of the state, be kept confidential, be used only as expressly authorized and returned at the contractor's expense to the F.O.B. point properly identifying what is being returned.

21. **PATENTS OR COPYRIGHTS:** The contractor agrees to indemnify and hold the State harmless from all claims, damages and costs including attorneys' fees, arising from infringement of patents or copyrights.

22. **ASSIGNMENT:** Any contract entered into pursuant to this invitation for bid is not assignable nor the duties thereunder delegable by either party without the written consent of the other party of the contract.

23. **OTHER REMEDIES:** In addition to the remedies outlined herein, the contractor and the state have the right to pursue any other remedy permitted by law or in equity.

24. **LACK OF FUNDS:** The state may cancel this contract to the extent funds are no longer legally available for expenditures under this contract. Any delivered but unpaid for goods will be returned in normal condition to the contractor by the state. If the state is unable to return the commodities in normal condition and there are no funds legally available to pay for the goods, the contractor may file a claim with the Arkansas Claims Commission. If the contractor has provided services and there are no longer funds legally available to pay for the services, the contractor may file a claim.

25.DISCRIMINATION: In order to comply with the provision of Act 954 of 1977, relating to unfair employment practices, the bidder agrees that: (a) the bidder will not discriminate against any employee or applicant for employment because of race, sex, color, age, religion, handicap, or national origin; (b) in all solicitations or advertisements for employees, the bidder will state that all qualified applicants will receive consideration without regard to race, color, sex, age, religion, handicap, or national origin; (c) the bidder will furnish such relevant information and reports as requested by the Human Resources Commission for the purpose of determining compliance with the statute; (d) failure of the bidder to comply with the statute, the rules and regulations promulgated thereunder and this nondiscrimination clause shall be deemed a breach of contract and it may be cancelled, terminated or suspended in whole or in part; (e) the bidder will include the provisions of items (a) through (d) in every subcontract so that such provisions will be binding upon such subcontractor or vendor.

26.CONTINGENT FEE: The bidder guarantees that he has not retained a person to solicit or secure this contract upon an agreement or understanding for a commission, percentage, brokerage or contingent fee, except for retention of bona fide employees or bona fide established commercial selling agencies maintained by the bidder for the purpose of securing business.

27.ANTITRUST ASSIGNMENT: As part of the consideration for entering into any contract pursuant to this invitation for bid, the bidder named on the front of this invitation for bid, acting herein by the authorized individual or its duly authorized agent, hereby assigns, sells and transfers to the State of Arkansas all rights, title and interest in and to all causes of action it may have under the antitrust laws of the United States or this state for price fixing, which causes of action have accrued prior to the date of this assignment and which relate solely to the particular goods or services purchased or produced by this State.

28. DISCLOSURE: Failure to make any disclosure required by Governor's Executive Order 98-04, or any violation of any rule, regulation, or policy adopted pursuant to that order material breach of the terms of this contract. Any contractor, whether an individual or entity, who fails to make the required disclosure or who violates any rule, regulation, or policy shall be subject to all legal remedies available to the agency.
