# AAPPA Spring 2004 Conference



The Arkansas Adult Probation and Parole Association Spring Conference will be held at the Holiday Inn City Center, located at 700 Rogers, Avenue, Fort Smith, AR. 72901 on March 24 & 25, 2004. DCC will pay for one night's lodging (Wednesday night) and the room rate for an additional night is \$62.36 (including tax). A credit card is needed to reserve the room. Mention AAPPA to get this special rate. You must live outside the 50-mile radius of Ft. Smith in order for DCC to pay your lodging. We advise early reservations since rooms are limited. To make reservations, call the Holiday Inn City Center at 1-800-HOLIDAY or 479-783-1000.

Directions: From I-40 West to Exit 1 Dora/Ft. Smith. There will be several sharp curves and you will go through the "Dora bottoms" for 4.5 miles to Hwy 64 East. Once you cross the river bridge go to 6<sup>th</sup> St. and turn right 1 block then turn left 1 block. The Holiday Inn City Center is located at 700 Rogers, Avenue, Fort Smith, AR. 72901.

Pre-conference activities will kick off at noon on Tuesday March 24, 2004 with a co-ed golf tournament. This year's tournament will be a 2-person scramble instead of a 4-person scramble. The cost is \$20 per person (confirmed). Contact David Landers to sign your team up.

West on I-40: Take Exit 20 – Dyer and go left 0.4 miles to Hwy 64. Go right on Hwy 64 (west) for 2.6 miles. The course will be on the left.

East on I-40: Take exit 13 – Hwy 71 and go right 0.4 miles to highway 64. Go left on Hwy 64 (east) for 4.3 miles. The course will be on the right.

The hospitality room will be open at 5 pm on Tuesday and Wednesday nights with a DJ providing entertainment beginning at 8 pm. In addition, the Association will provide food on Tuesday night, a buffet lunch on Wednesday, and hamburgers/hotdogs on Wednesday night.

## AAPPA Conference

The Arkansas Adult Probation and Parole Association Fall Conference will be held at the Velda Rose Resort Hotel located at 218 Park Avenue in Hot Springs National Park, Arkansas 71901. We advise early reservations since rooms are limited.
