The conference is being co-sponsored by the Arkansas Adult Probation And Parole Officers Association, and The Center For Sex Offender Management. Presenters will come from around the country in affiliation with various law enforcement related support agencies.

In you live more than 50 miles from Hot Springs, DCC will pay for two nights lodging, by direct billing, for all Association Members. Due to budget concerns and room availability, as well as room rates based on double occupancy, we are recommending two people per room. If you wish to room alone, or share a room with a person who is not a Association member, you will be responsible for one half the cost. Room rates are \$60.00 per night + tax.

DCC will also pay the conference registration fee of \$40.00. Your annual membership fee of \$20.00 is due at the conference. The conference will be almost two full days with a lunch buffet provided by the Association on Wednesday and Thursday. The Association will host a hospitality room on Tuesday and Wednesday nights. Association Officers and Board members will be elected at a business meeting held at the conclusion of the training session on Wednesday.

AAPPA Fall Conference



The Arkansas Adult Probation and Parole Association Fall Conference will be held September 24-25, 2003, at the Velda Rose Resort Hotel and Spa, in Hot Springs. The hotel is located at 217 Park Avenue. There are additional rooms reserved at the Majestic Hotel, 101 Park Avenue. You must call the hotel directly at 1-888-624-3311, and mention AAPPA.

Pre-conference activities will kick off at noon on Tuesday, September 23rd, with a 4-Person scramble golf tournament. Tee off will be 12:30 p.m. at the Lake DeGray State Park, located on Highway 7, six miles north of I-30 at Caddo Valley / Arkadelphia exit #78. The cost is \$27.32, and includes green fees and cart. The Educational Sessions on Wednesday and Thursday will be presented by the Center For Sex Offender Management. The two day sessions will focus on the management of adult sex offenders in the community. The training will provide an overview of emerging best practices and research in the management of this population in the community. The sessions will discuss the etiology of sexual abuse, sex offender typologies, specialized supervision approaches and strategies, specialized assessment and treatment, secondary trauma, and collaboration.

In addition to probation and parole staff, the training will be relevant to judges, prosecutors, treatment providers, victim advocates, and others who share responsibility for managing sex offenders in the community.

Early registration will be from 5:00 p.m. to 7:00 p.m. on Tuesday evening. The Hospitality Room will open at 5:00 p.m. on Tuesday and Wednesday evening.

Registration will begin on Wednesday morning at 8:00 a.m. The Sessions will begin at 9:00 a.m. You must attend all training sessions to receive credit. The deadline is August 31, 2001. After the deadline you will only be allowed on the shuttle if there is space available.
