If you live more than 50 miles from Ft. Smith, DCC will pay both nights lodging, by direct bill, for all Association members. Due to room availability and budget constraints, as well as room rates based on double occupancy, we are recommending two people per room. Cost of rooms is \$68.55(tax included) per night.

IN ADDITION, IF YOU REGISTER AFTER THE DEADLINE A NON-REFUNDABLE \$10 LATE REGISTRATION FEE WILL APPLY. IN ORDER TO REGISTER, YOUR AREA MANAGER OR ASST. DRIVING DIRECTIONS TO THE HOTEL

Directions to the hotel from Little Rock:

1. Take I-40 W going toward Ft. Smith
2. Merge onto I-540W/US 71S via Exit 7 toward Van Buren/Ft. Smith
3. Merge onto AR 59N/S 4th Street via Exit 3 toward Van Buren
4. Turn Left onto US 64W/Broadway Street S. Continue to follow US 64W
5. US 64 W becomes S 10th Street
6. Turn Right onto Rogers Avenue
7. End at Holiday Inn Ft. Smith-City Center
700 Rogers Avenue, Ft. Smith, AR 72901.
